**CHARGES UPON REMAND:**

**IT IS HEREBY ORDERED** that, pursuant to the *Presiding Judge Administrative Order Establishing a Statewide Bail Schedule*, the defendant named above is released on the condition that the defendant promises to appear at all scheduled hearings as required.

**CONDITIONS OF RELEASE**

The court finds that additional conditions are necessary to assure the defendant's appearance or to protect the alleged victim or the community. IT IS FURTHER ORDERED that the conditions of release below are imposed and are effective immediately. If the defendant is arrested for violating the conditions of release set forth in this order, then this order is revoked and the defendant shall be held without bail until a new bail order is set.

1. The defendant shall obey all court orders and all federal, state, and local laws and ordinances.
2. The defendant shall appear in court when ordered.
3. If represented by an attorney, the defendant shall maintain contact with the attorney.
4. If represented by an attorney, the defendant shall notify the defendant's attorney, who shall notify the prosecuting authority and the court, not more than 24 hours after the defendant changes residence.
5. If unrepresented, the defendant shall notify the prosecuting authority and the court not more than 24 hours after changing residence.
6. The defendant shall not leave the State of Alaska.
7. The defendant shall not associate with or contact, directly or indirectly, alleged victims in this case.
8.  The defendant shall not consume or possess alcohol.
