**STANDING MASTER
APPOINTMENT ORDER**

Magistrate Judge _____ is appointed Standing Master for the _____ Judicial District pursuant to Civil Rule 53 and the applicable Alaska Rules of Court referenced below, to hear and report on the following matters:

- uncontested divorces, dissolutions of marriage, and motions in contested domestic relations matters pursuant to AS 25.20 through 25.30 as may be referred by a Superior Court Judge;
- probate matters pursuant to AS 13 (including acting as registrar), and Rules 2(b)(2)(A), (B), (D), (E) and (F) of the Alaska Rules of Probate Procedure;
- minor settlements pursuant to Civil Rule 90.2;
- matters relating to mental health and alcohol commitment proceedings under AS 47.30, AS 47.37 and Rule 2(b)(2)(C) of the Alaska Rules of Probate Procedure;
- name changes pursuant to AS 09.55.010;
- child in need of aid proceedings pursuant to AS 47.10 and Rule 4 of the Alaska Child in Need of Aid Rules;
- delinquency proceedings pursuant to AS 47.12 and Rule 4 of the Alaska Delinquency Rules;
- adoption proceedings pursuant to AS 25.23 and Rule 3 of the Alaska Adoption Rules;
- creditor-debtor matters pursuant to AS 09.35 through AS 09.38 and Rule 69(b)(1) of the Alaska Rules of Civil Procedure;
- residential forcible entry and detainer matters pursuant to AS 09.45.070 when the value of the arrears and damage to the property does not exceed \$100,000;
- other _____

At the conclusion of each matter heard, the magistrate judge as standing master shall prepare such reports, recommendations, proposals for judgment, orders, findings, or dispositions, as appropriate, and in accordance with the applicable statutes, Rules of Court, and directives of the assigned superior court judge.

This appointment supersedes any previous standing master appointment order, and terminates upon revocation of this order, or upon termination **of the appointee's employment as a** magistrate judge with the Alaska Court System, whichever occurs first.
