**RELEASE CONDITIONS**

- Defendant must reside with a Third Party Custodian (Custodian).
- The court has approved \_\_\_\_\_  
**[An Acknowledgment by Custodian(s) MUST be signed by Third Party Custodian(s) and filed before release].**
  - Sight and sound (24 hours per day) ( except \_\_\_\_\_)
  - Monitoring (Custodian must know where defendant is at all times):

  - Do not** return to the residence of victim(s) named in the complaint (even if you live there).
    - If this box is checked you may return to said residence **once** in the company of a **peace officer** to retrieve necessary personal belongings.
  - Do not** have **any** contact, **direct or indirect**, with any victims or witnesses named in the complaint: \_\_\_\_\_
  - Do not** talk about this case with any victims or witnesses named in the complaint.
  - Do not** return to Dillingham except for court hearings, medical or alcohol treatment, and emergencies.
    - Upon release from custody, go **directly** to the airport for the next flight to \_\_\_\_\_

- You must** submit to a search of your person, personal property, residence, vehicle or any vehicle over which you have control, upon probable cause, for the presence of:
  - alcoholic beverages.  illegal drugs or drug paraphernalia.
- Do not** operate any motor vehicle
  - unless properly licensed and insured.
  - if you have consumed any alcohol within the past 12 hours.
  - at any time.

The magistrate judge is assigned to noncriminal violations, pretrial motions and changes of plea in misdemeanors, and pre-indictment hearings in felonies.

**DEFENDANT'S ACKNOWLEDGEMENT**

**I have reviewed this order and I promise to appear at all scheduled hearings and to comply with all the release conditions in this order. I understand that if I fail to do so, I will be subject to the following penalties:**

1. I may be arrested without a warrant;
2. The appearance bond may be forfeited if I fail to appear;
3. The performance bond may be forfeited if I violate a condition of release other than the requirement to appear;
4. I may be held in contempt of court; and
5. I may be charged with one or more of the following additional crimes:
  - "Violation of a Condition of Release" under AS 11.56.767
  - "Failure to Appear" under AS 11.56.730
  - "Unlawful Contact" under AS 11.56.750 if I violate an order prohibiting contact with a victim or witness.
