ORDER AND CONDITIONS OF RELEASE

IT IS ORDERED that the defendant named above be released:

- OWN RECOGNIZANCE. Defendant does not have to post bail.
Defendant to execute the following bonds:
APPEARANCE BOND in the amount of \$
Unsecured 10% Cash 100% Cash Only 100% Cash or Surety
PERFORMANCE BOND in the amount of \$ cash only.
THIRD PARTY CUSTODIAN (print name)
24-hour sight and sound
The third party may remand the defendant to jail for any reason.
Defendant to obey the following conditions:
Obey all court orders and all federal, state, and local laws.
Appear in court when ordered.
Maintain contact with your attorney, if represented: weekly every 2 weeks.
Tell your lawyer in 2 business days of changes to home or mailing address & phone #.
Tell the court in writing in 5 days of any change in mailing address or phone #.
Do not depart without court permission.
Do not possess or consume alcohol/illegal drugs (including marijuana) or have either in your residence, and do not go to bars or liquor stores.
Participate in a 24/7 monitoring program:
Be tested for alcohol two times per day, each day.
Be tested for illegal drugs times per week.
Report to Alaska Monitoring and Drug Testing at 508 S. Willow, Suite C, between 6 pm - 9 pm on day of release. Pay all reasonable fees.

Effective immediately, you must not directly or indirectly contact:

Submit to a search (including PBT) of person/home/vehicle if officer has reasonable suspicion of illegal drug or alcohol possession or consumption.
