GUIDELINES

Content: All entries should address in some form the contest theme: "Fairness, Diversity, Equality: Our Justice System Depends on Them; What Do They Mean to You?" Entries will be judged on a range of factors, including artistic quality, originality, and strength of expression in conveying the concepts involved. Only original works will be accepted.

Artist Statements: All entries should be accompanied by a brief statement from the artist describing the piece and how it addresses the contest theme.

Size: Items should measure no larger than 24" x 36."

Identifiable People: Artwork submitted should not feature images of identifiable people unless accompanied by a release from each person featured that includes their names and contact information and a statement authorizing the use of their image.

Use of Art by Contest Sponsors: All art pieces submitted to the contest are subject to use by contest sponsors, both in hard copy and online, for displays, exhibits, publications, and other efforts to educate the public about our system of justice. Contest entries not selected for prizes may be returned upon request.
