

PLEASE TAKE NOTICE that a petition to terminate your parental rights to GG, a male child, born in Juneau, Alaska, on 02/19/2013, has been filed in the Juneau Superior Court, First Judicial District at the Dimond Courthouse, 123 4th Street, Juneau, Alaska. The petition alleges that your parental rights should be terminated because you are not available to care for your child and you have abandoned such child.

If the petition is granted you will be relieved of all future parental rights and responsibilities, and all legal relationships between you and the child will be terminated.

A hearing on the petition has been scheduled for **3/13/15 at 9:00a.m.**, before the Superior Court for the State of Alaska, 123 4th Street, Juneau, Alaska. If you live out of town and cannot appear in person you may be present telephonically by calling the court at the start of the hearing time at the toll-free teleconference number 1-800-768-2983; access code 4634742#; followed by the #.


If you have any objections to the petition, you may appear at the courthouse at the above time and place to present them in person, or you may send them in writing to
