**SUMMONS AND NOTICE OF HEARING
TO TERMINATE PARENTAL RIGHTS**

To: Shawn Peterson (11/29/1983)

YOU ARE HEREBY SUMMONED to appear in a termination of parental rights hearing regarding the above-referenced Children's Proceeding. The hearing will be held before the Superior Court for the State of Alaska, located at 415 Main Street, Ketchikan, Alaska. The termination of parental rights trial will be held on July 7, 2015, at 11:00 a.m. The petition alleges that the child named above is a child in need of aid and that the best interests will be served by terminating your parental rights.

You have the right to be represented by an attorney. If you cannot afford to hire an attorney, you may ask the court to appoint one for you at public expense. To see if you qualify for a court appointed attorney, you must contact the court.


If you live outside of the Ketchikan area, you may participate telephonically by calling, at the start of the hearing, 1-800-768-2983, conference code 2253195#. If the court has already signed on, you will be asked to identify yourself and press #. If the court has not yet signed on, you will be asked to wait and be put on hold; when the court is ready, you will be prompted to identify yourself and press #.

If the petition is granted you will be relieved of all future parental rights and responsibilities, and all legal relationships between you and the child will be terminated.


