The relief demanded is approximately \$57,584 (the value of the Plaintiffs' missing coin, bill and ingot collection), plus interest, costs, and attorney's fees including an award of actual attorney's fees pursuant to AS 45.50.537; and for treble damages pursuant to AS 45.50.531; and such relief as the court deems appropriate. You have been made a party to this action because you are liable as an individual for your acts and for your work for Dry Out Systems of Alaska as an employee and/or independent contractor at the Plaintiffs' residence beginning on November 19, 2012.
