11 PLEASE TAKE NOTICE that a Petition for Termination of Parental Rights  
12 under A.S. 47.10.080(c)(3) has been filed with the Superior Court, Fourth Judicial  
13 District, Fairbanks, Alaska concerning the above minor, who is believed to be your  
14 child. The petition alleges that your parental rights should be terminated because you  
15 are not available to care for your child and you have abandoned your child. Additional  
16 grounds for termination could include those listed in A.S. 47.10.011. **This petition**  
17 **could result in an order terminating your parental rights to this child.** A copy of the  
18 petition is on file at the Fairbanks Courthouse for the Fourth Judicial District at 101  
19 Lacy Street, Fairbanks, Alaska 99701.

20 The pretrial conference is scheduled for **June 23, 2015 at 3:15 PM.** The  
21 termination trial is scheduled for **July 6, 2015 at 8:30 AM.** The hearings will be held in  
22 courtroom 304, at the Fairbanks Courthouse for the Fourth Judicial District at 101 Lacy  
23 Street, Fairbanks, Alaska 99701. You may appear telephonically by calling 452-9350  
24 prior to the hearing.

25 You have the right to be represented by an attorney at the hearing and an attorney  
26 has been appointed to represent you at state expense. Your attorney is Thomas Chapman  
of the Public Defender Agency. Mr. Chapman can be contacted by telephone at 1(907)
