PLEASE TAKE NOTICE that a petition for the termination of your parental rights to the above children has been filed, under AS 47.10.080 and AS 47.10.088, with the Alaska Superior Court, Fourth Judicial District, in Fairbanks, Alaska. The above children are believed to be your children. The petition alleges that your parental rights should be terminated because you are not available to care for your children and you have abandoned your children. Additional grounds for termination could include any of those listed in AS 47.10.011. At present, the petition alleges the above children are children in need of aid under (1) abandonment, (6) substantial physical harm, (8) mental injury, (9) neglect, and (10) substance abuse. **This petition could result in an order terminating your parental rights to these children.** A copy of the petition is on file at the Fairbanks Courthouse for the Fourth Judicial District, located at 101 Lacy Street, Fairbanks, Alaska 99701.


The termination of parental rights trial in this matter is scheduled for **FEBRUARY 1, 2016 at 8:30 AM** in courtroom 304, at the Fairbanks Courthouse for the Fourth Judicial District, located at 101 Lacy Street, Fairbanks, Alaska 99701. A pretrial conference is scheduled for January 26, 2016, at 3:15 p.m. in the same location. You may appear telephonically at a hearing or trial by calling (907) 452-9350 prior to the hearing or trial.

You have the right to be represented by an attorney at the hearing and an attorney has been appointed to represent you at state expense. Your Attorney is Jennifer Hite and/or Amy Bennett of the Alaska Public Defender Agency. They may be contacted by telephone at (907) 458-6800. The attorneys' address is 529 5th Avenue, Fairbanks, Alaska 99701.

If you or your attorney cannot appear at the hearing, you must file with the court a response to the petition prior to the date and time set forth above for the termination trial.
