13 PLEASE TAKE NOTICE that a petition for the termination of your parental rights

15 Alaska Superior Court, Fourth Judicial District, in Fairbanks, Alaska. The above children
16 are believed to be your children. The petition alleges that your parental rights should be
17 terminated because you are not available to care for your children and you have
18 abandoned your children. Additional grounds for termination could include any of those
19 listed in AS 47.10.011. At present, the petition alleges the above children are children in
20 need of aid under (1) abandonment, (4) medical treatment, (6) substantial physical harm,
21 (8) mental injury, (9) neglect, (10) substance abuse, and (11) mental health issues. **This**
petition could result in an order terminating your parental rights to these children.
