13 PLEASE TAKE NOTICE that a Petition for Adjudication of Child in Need of
14 Aid and Custody has been filed with the Superior Court, Fourth Judicial District,
15 Fairbanks, Alaska concerning the above minor, who is believed to be your child. The
16 petition alleges that the above child is a child in need of aid and that the above child
17 should be placed in the department's custody because a parent is not available to care
18 for your child and has abandoned your child. Additional grounds for an adjudication
19 could include those listed in A.S. 47.10.011 (1) abandonment, (4) health care, (6)
20 physical harm, (8) mental injury, (9) neglect, and (10) substance abuse. **This petition**
21 **could result in an order placing your child in the department's custody for a**
22 **period not to exceed two years.** A copy of the petition is on file at the Fairbanks
23 Courthouse for the Fourth Judicial District at 101 Lacy Street, Fairbanks, Alaska 99701.

24 The termination trial is scheduled for **April 27, 2015 at 8:30 AM** in courtroom
25 402, at the Fairbanks Courthouse for the Fourth Judicial District at 101 Lacy Street,
26 Fairbanks, Alaska 99701. The pretrial conference is scheduled for **April 20, 2015 at**
3:15 PM. You may appear telephonically by calling 452-9319 prior to the hearings.

You have the right to be represented by an attorney at the hearing and an attorney
has been appointed to represent you at state expense. Your attorney is Brent Bennett of
