PLEASE TAKE NOTICE that a petition for the termination of your parental rights under A.S. 47.10.080 and A.S. 47.10.088 has been filed with the Superior Court, Fourth Judicial District, Fairbanks, Alaska concerning the above minors, who are believed to be your children. The petition alleges that your parental rights should be terminated because you are not available to care for your children and you have abandoned your children. Additional grounds for termination could include those listed in A.S. 47.10.011 and could include that the children are children in need of aid under (1) abandonment, (2) incarceration, (3) unwilling caregiver, (4) need for medical care, (5) runaway, (6) possibility of physical harm, (7) sexual abuse, (8) mental injury, (9) neglect, (10) substance, (11) mental health issues, and (12) criminal act. This petition could result in an order terminating your parental rights to these children. A copy of the petition is on file at the Fairbanks Courthouse for the Fourth Judicial District at 101 Lacy Street, Fairbanks, Alaska 99701.

The termination of parental rights trial is scheduled for **June 6, 2016 at 8:30 A.M.** A pretrial conference will be held on **May 23, 2016 at 3:00 P.M.** These hearings will be held in courtroom 402, at the Fairbanks Courthouse for the Fourth
