8 THIS IS TO NOTIFY YOU THAT:

9 1. J.M.S. has filed a petition in the above-entitled court for
10 the adoption of T.B.R.D., born September 4, 2007, in Fairbanks, Alaska.
11 The minor child's biological mother, M.L.S., consents to the adoption.

12 2. A Decree of Adoption in this case will relieve you of any and
13 all parental rights and responsibilities which may exist between you and
14 the minor child and will terminate any parent-child relationship between
15 the minor child and yourself, including terminating any rights of
16 inheritance and visitation. The adoption will create a legal parent-
17 child relationship between the minor child and the petitioner. The minor
18 child's name will become T.B.R.D.S.


19 3. A hearing on the Petition will be held at Courtroom 301,

23 not required because you were never married to the biological mother of
24 the minor child nor did you acknowledge, adopt, or otherwise legitimate

4. If you question the statements contained in this Notice regarding your parental rights and/or are unsure of your rights in this matter, you are urged to contact an attorney. Should you wish to consult an attorney but cannot afford to pay for one, you may qualify to have an attorney appointed by the Court to represent you. You should contact the Court if you wish an appointed attorney. Unless you respond to this Notice by contacting the Court before the hearing or by appearing at the hearing, the Court may grant the Petition without further notice to you.
