22 The adjudication trial is scheduled for September 28, 2015 at 8:30 AM in
23 courtroom 403, at the Fairbanks Courthouse for the Fourth Judicial District at 101 Lacy
24 Street, Fairbanks, Alaska 99701. You may appear telephonically by calling 452-9370
25 prior to the hearing.

26 You have the right to be represented by an attorney at the hearing and an attorney
may be appointed to represent you at state expense. You may request an attorney at the
