PLEASE TAKE NOTICE that a petition for adjudication of child in need of aid under AS 47.10.011 has been filed with the Alaska Superior Court, Fourth Judicial District, in Fairbanks, Alaska, concerning the above child, who is believed to be your child. The petition currently alleges that the above child should be adjudicated a child in need of aid under AS 47.10.011 subsections (1) abandonment, (2) incarcerated parent, (3) unable or unwilling caregiver, (4) medical neglect, (7) sexual abuse, (8) mental injury, (9) neglect, (10) substance abuse, and (11) mental health issues. Additional grounds for adjudication could include any of those listed in AS 47.10.011. **This petition could result in an order placing your child in the custody of the Alaska Department of Health and Human Services' Office of Children's Services for a period not to exceed two years.** A copy of the petition is on file at the Fairbanks Courthouse for the Fourth Judicial District, located at 101 Lacey Street, Fairbanks, Alaska 99701.

The adjudication trial in this matter is scheduled for **APRIL 25, 2016, at 8:30 AM**, in courtroom 402, at the Fairbanks Courthouse for the Fourth Judicial District, located at 101 Lacy Street, Fairbanks, Alaska 99701. You may appear telephonically by calling (907) 452-9319 prior to the hearing or trial.

You have the right to be represented by an attorney at the hearing and an attorney has been appointed to represent you at state expense. Your Attorney is Thomas Chapman
