PLEASE TAKE NOTICE that a petition for adjudication of children in need of aid has been filed with the Superior Court, Fourth Judicial District, Fairbanks, Alaska concerning the above children, one of whom is believed to be your child. The petition alleges that the above-captioned children should be adjudicated children in need of aid under AS §47.10.011. Grounds for adjudication could include those listed in A.S. §47.10.011 (1) abandonment, (2) incarceration, (3) unwilling caregiver, (4) need for medical care, (5) runaway, (6) possibility of physical harm, (7) sexual abuse, (8) mental injury, (9) neglect, (10) substance, (11) mental health issues, and criminal act. **This petition could result in an order adjudicating your child as a child in need of aid.** A copy of the petition is on file at the Fairbanks Courthouse for the Fourth Judicial District at 101 Lacy Street, Fairbanks, Alaska 99701.

The adjudication trial is scheduled for the week of **July 11, 2016 at 8:30 AM** in Courtroom 403, at the Fairbanks Courthouse for the Fourth Judicial District at 101 Lacy Street, Fairbanks, Alaska 99701. A pretrial conference is scheduled for June 30, 2016 at 2:45 PM in the same location.

You have the right to be represented by an attorney at the hearing and an attorney has been appointed to represent you at state expense. Gary Stapp has been appointed to represent you. You may reach him at (907) 452-4452.
