NOTICE OF HEARING

TO: Domingo Abagon

THIS IS TO NOTIFY YOU THAT:

1. A petition has been filed in the above entitled court for the adoption of your child, S.A.P.
2. Petitioner has alleged that your consent to the adoption of said child is not required for the reason that you have failed to communicate meaningfully with the child for a period of at least one year.
3. The effect of entry of a decree of adoption would be to forever terminate your parental rights and obligations and end all legal relationships between the adopted person and you, including child support, and to create the relationship of parent and child between the petitioner and the adopted person. You would have no rights of visitation after the adoption.
4. A hearing on the petition will be held in the courtroom of the above entitled court on the **18th day of May, 2016 at the hour of 2:00 p.m.**, Alaska Standard Time in **Courtroom 303**. If you have any objections to the granting of the petition, your objections must be reduced

5. If objections are filed, the hearing will be rescheduled at a later date to give you an opportunity to appear before the court to testify in support of your objections. If no objections are received by the court prior to the date of hearing, the hearing will proceed as scheduled and the adoption may be granted without further notice to you.


