This action is for failure to pay for materials and equipment purchased.

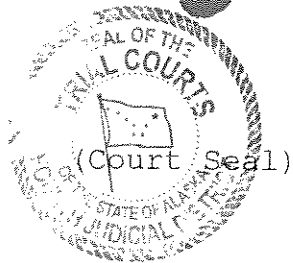
The relief demanded is \$6,398.45 plus pre-judgment interest, costs and attorneys fees.
