The adjudication trial is scheduled for **June 6, 2016 at 8:30 AM.** A pretrial conference will be held on **May 23, 2016 at 3:15 PM.** These hearings will be held in courtroom 402, at the Fairbanks Courthouse for the Fourth Judicial District at 101 Lacey Street, Fairbanks, Alaska 99701.
