PLEASE TAKE NOTICE that a petition for the termination of your parental rights under A.S. 47.10.080 and A.S. 47.10.088 has been filed with the Superior Court, Fourth Judicial District, Fairbanks, Alaska concerning the above children, who are believed to be your children. The petition alleges that your parental rights should be terminated because you are not available to care for your child and you have abandoned your child. 
